### a. Envision Palo Cedro (Kelly Lindblom / Laura Porzio)

Envision Palo Cedro - Shasta County - Opticos Event Saturday, Meeting at the HS. The very first group of the day was a cluster. Different feel between the groups with some going smoother than others and some didn't have enough education about what was happening. Lots of confusion on what was going on in the first group. The following groups went more smoothly. Time estimate was off - going longer than planned. Pros and Cons with the day but more sessions are being planned.

There were two sessions in the afternoon:

Walking Tour was interesting. The Visioning afternoon group was off to a rocky start without starting off with explaining what was going on. It would have been much better to go over the purpose of what has been done by starting with the history of why Envision Palo Cedro was started. ## 9. Public Comment -

1. Kelly Landry asked what the Envision Project is trying to get out of the specific plan process. The goal of Envision has always been to find out what the residents of Palo Cedro would like in terms of managing growth then working to implement those wishes to protect the culture of our community in the long run. There was conversation regarding the housing requirements in the grants. County approached us because we were further along in the process than the other areas that are supposed to have a specific plan. We've been doing it on our own with volunteers since the Housing Allotment issue 4 years ago. Feedback has shown that people would like to create a town that is cohesive in some way with a cute little downtown area where visitors spend their \$ and go home. Aging in place housing has come up also. Seniors who live who'd like to downsize in the area need places to stay. So do young families who grew up here and want to move back with their kids. A specific plan broadens the possibilities and makes it easier for the landowner. Part of the grants for the specific plan is increased by right housing. Doesn't mean that they have to build anything. Simply means there could be more options for projects IN THE DOWNTOWN CORRIDOR. We are talking about a very small area of PC which would help protect the rural areas better. Jason Hull asked who had read the Grants in the plan? Laura Porzio has. He felt high density is what they want. Laura pointed out that it doesn't have to be high density based on the grant. Ron Holmstrom shared his thoughts on the Grants. Increased housing is what he's reading and used San Ramon is an example. There was a discussion on how the Chamber came to be working on this with the city. Some people suggested reconsidering the grant. Laura requested those who were hesitant meet with the county before making any decisions. They agreed. *Laura will set up a meeting.*
